- c. The ACOE is inviting comments on proposed additions to "examples of evidence" associated with Optometric Residency Standards 2.1 and 2.4. These are the standards that specify a written curriculum and the knowledge, skills, and behaviors required to attain the advanced competencies in the program's mission, goals, and objectives. They are now proposing a list of advanced copies may be submitted as examples of evidence.
 - i. A program may choose to provide some, all, or none of these examples as long as it provides evidence to demonstrate compliance.
